## NCDAA Annual Sessions Awards

THE EDNA ZEDAKER LOYAL ASSISTANT AWARD, sponsored by the Past President's Council, will be presented to the member of NCDAA, who submits the longest record of consecutive employment, with one employer, providing she has not previously received the award. The recipient must be registered at the NCDAA Annual Session and be present at the awards ceremony to receive this award. (The term consecutive employment shall refer to an assistant actually employed by but not married to her employer.) A notarized statement giving date of original employment and stating that she has been a member of the NCDAA for at least two years must be given to the NCDAA Secretary by the designated date. This must be signed by her employer and the President and Secretary of her society. It must be two consecutive years just prior to application of the award, that he or she has been a member of NCDAA.

THE DR. WILLIAM H. OLIVER ACHIEVEMENT AWARD, sponsored by Linda W. Clark, CDA, will be presented to the member, who in the opinion of the Executive Board, has done the most outstanding work for the NCDAA and for dental assistants.

THE ETHEL EARL ACHIEVEMENT AWARD, sponsored by the family of Faye J. Watkins, CDA will be presented to a member of the NCDAA, not on the Executive Committee, who in the opinion of the Executive Board, has done the most outstanding work for the Association and for dental assistants.

THE CHARLOTTE LABORATORY ATTENDANCE AWARD will be presented to the local society having the largest percentage of members registered at the Annual Session.

THE JOE BAKER COOPERATION AWARD will be presented to the local society that has given the best cooperation to the officers and committees. The Executive Committee will recommend a society to be approved by the Executive Board.

THE AILEEN CROOM MEMBERSHIP AWARD will be presented to the local society having the largest percentage of increase in active membership since the close of the last Annual Session of NCDAA.

THE HARRY LEMMONS MEMBERSHIP AWARD will be presented to the local society having the second largest percentage of increase in active membership since the close of the last Annual Session.

Newman will be presented to a local society or ACTIVE membership status individual for recognition of volunteer service to underserved populations for clinical, educational, or monetary support. This work is performed in the local community, state or international levels of service.

## NCDAA VOLUNTEERISM AWARD

NCDAA will be sponsoring a Volunteerism Award available for a regular ACTIVE member or a local society to be awarded at the Annual Session at North Myrtle Beach. Kelley introduced herself as NCDAA Vice-President and explained that she would be presiding over the Executive Board Meeting in the absence of President Diane Gwaltney, as she was attending her son's wedding in Florida.

Secretary, Lolly Pardue called the roll and a quorum was present to conduct business.

Vice-President Curtin shared correspondence from ADAA regarding Annual Conference and a thank you note from Kristy Eddleman for the baby gift.

Treasurer, Kristy Eddleman, presented the Treasurer's Report, which had been placed on the table at the back of the room and asked if there were any questions. Linda recommended that President Dianne Gwaltney and/or our advisor, Dr. Elliott speak to NCDS regarding the rate NCDAA receives per dental assistant registered at Annual Session. At the current time, the rate is \$35.00 per registered dental assistant.

The Treasurer's Report was placed on file for audit.

#### NEW BUSINESS

#### ADAA ANNUAL CONFERENCE REPORT 2009

It was a tremendous honor and privilege for me to lead the NCDAA delegation to our Annual Conference in beautiful Honolulu, Hawaii, Sept. 30-Oct. 4, 2009. Charyl Allison, Kelley Curtin, Carol Sell, Lolly Pardue, Rita Millikan, and I (your President, Dianne Gwaltney) were among 149 other credentialed voting members present at Annual Conference. Our trip began with a few challenges, like missing our connecting flight in San Francisco. We had to spend that first night in San Francisco but were able to get a flight out the next morning. We arrived in Honolulu early in the afternoon, but by the time we located luggage and reached our hotel, it was almost 4:00pm. We missed the first day of meetings but fortunately, Carol Sell had gone out earlier and was there to cover the first day for us. Charyl Allison had also taken a different flight and was also there to represent us that first day.

President Stephen Spadaro opened the First House of Delegates meeting with welcomes and greetings. Joy Hershimo of Hawaii (who I had the "joy" of meeting several years ago in Anaheim, CA) presented fresh leis to the Governing Board and the District Trustees. Greetings were presented from the US Air Force, the US Army, and Past President of the Canadian ADAA. It was also very exciting to have a Chinese Delegation present for the first time. Representatives from the delegation were introduced and each spoke. Highlights of the First House were the recognition of first time delegates, state and local presidents, the past presidents of ADAA, and life and retired members. Also, the new local societies were recognized. We were very proud of our new local, Sandhills DAS, in Rockingham, and to Rita Millakin for making this happen. President Spadaro was presented a flag of the United States of America that was flown over the capitol in Washington, DC, by Past President Kimberly Bland.

On Friday morning, we attended the Vision Presentation, which gave everyone an opportunity to ask questions about the proposed e-membership. ADAA feels like they have tried every option to increase membership over the past years. They stressed that the younger generation is connected to technology and for us to connect with them, we must get on the same page. Currently the ADAA website is getting at least 70,000 hits a month. This will give ADAA the opportunity to expand our horizons, get into the electronic age, and reach out to the other 97% of dental assistants in the U.S. who are not currently members of ADAA. Yes, there are 250,000 dental assistants in the U. S. and only 3% are ADAA members. Not only that, it will give us the capability of networking with dental assistants in other countries.

Reference Committees met following the Vision Presentation. Lolly covered the Reference Committee on Budget. Lolly reported that this was very beneficial to her since she is serving her second term as NCDAA Budget and Finance Chair. Two budgets were proposed for 2010 for the ADAA, one with the E-Membership and the other without. The budget containing the proposed E-Membership included the cost of new hardware and software to incorporate the program as well as additional part-time staff to administer the program which will be amortized over 2 years. It was estimated that the part-time staff would not be needed until the last 6 months of the 2010 if the initiative was approved by the ADAA House of Delegates. There was also some debate over the proposal to email the 2010 ADAA Delegate Handbook.

I covered the Bylaws Reference Committee. There was much discussion about the Proposed changes to the Bylaws, Article IV and V (the addition of a new membership category: E-Membership). After several members proposed amendments to the amendment, the straw vote of those attending was to recommend to the House of Delegates the addition of the E-Membership as proposed by the committee.

The Second House of Delegates convened on Saturday morning at 10:00am. Kelley reported on this meeting for us. President Spadaro announced the results of balloting on Friday evening. Natalie Kaweckyj, President-Elect, Claudia Pohl, Vice-President, and Susan Rexroat, Secretary. There was also election of trustees for several districts. Executive Director, Larry Sepin gave an update of the ADAA's financial status. The ADAA has had 11 years of profit and 15 consecutive years of profit from the Annual Conference. Bottom line is that the financial stability of the ADAA at this time is good. The Proposed Bylaw change concerning E-Membership was brought to a vote. It was a unanimous decision to adopt the amendment to the Bylaws Article IV and V. The proposed budget for 2010 with the E-Membership was also adopted. Executive Director Larry Sepin recognized the Officers and Trustees for the past year and presented gifts. He also said that "we made history today" referring to the adoption of the new membership category.

5th District brought greetings and invited everyone to Florida for 2010 Annual Conference in Orlando. This concluded the meeting.

The ADAA President's Gala was held on Saturday evening. The installation ceremony was beautiful, as usual. We enjoyed a wonderful meal and fellowship with each other as well as with our South Carolina friends. As one of our delegates stated, "the gala was a lot more elaborate than anything I had expected. I guess I just never expected anything that nice for dental assistants. They really made us feel so appreciated for what we do. It was an experience I will always cherish and remember." Another delegate stated, "although the conference was a marvelous experience, the wonderful fellowship with my fellow delegates surpassed anything I could put into words. I am fortunate to have gotten to better know these remarkable ladies that I serve with in NCDAA."

I would also like to personally thank Carol Sell for manning our Ways and Means Table and for all the hours she spent preparing for the event by making her beautiful jewelry. A special thank you as well to Nanette Hill, our Fourth District Trustee. She does an outstanding job representing us and keeping us abreast of everything. Again, we would all like to express our appreciation to NCDAA for this opportunity to serve you. I was extremely proud of this delegation, their professionalism and their desire to represent you well.

AFRICAN MISSION TRIP

I was given the opportunity recently to join a team going to the country of Senegal, Africa for a mission trip. Our team included Dr. Ronald Key, his wife Janet from Newton, NC, Dr. Stephanie Ballentine from Charlotte, NC and myself.

After prayerful consideration and discussion with my family, I decided this was another way God was expanding my territory. I had volunteered in my community and with NCDS Missions of Mercy, and I plan to continue to volunteer in those areas. Africa was a totally different adventure for me.

We arrived in the village of Bougoutoub after a 10 hour taxi ride, passing through the country of Gambia, within the country of Senegal, to arrive in the southern part of Senegal. We stayed at the home of missionaries, Lee and Donelle Kauffman. Our trip began January 23 through February 6, which was also winter in Africa. Temperatures there was 90 degrees during the day, I'm just glad it was winter. We were up every morning to the rooster crowing at 5:15. The village people had made is a clinic out of palm leaves, which was very nice and gave us privacy to work on the patients. We went to the clinic at daybreak to work each morning during the coolest time of the day. We were in a Jola-fonyi village so Stephanie and I had to be given a Jola name. My Jola name is Ida Sane and that's how I would introduce myself to the village people.

We saw 243 people from 16 villages while we were there, many walking two to three hours to be treated. Everyone was so appreciative of everything we did. This was a very humbling experience. The African women wore beautiful clothes, with vibrant colors. I had the opportunity to visit one of the local markets, buy material, and a local tailor made me an African dress.

The trip was an experience I will always treasure. I encourage all dental assistants to volunteer their time in whatever way you can as you are given opportunities.
